- BRB WILL TRACK YOUR CLIENT'S LOST BAG AND EXPEDITE ITS RETURN FOR THE FIRST 96 HOURS OF IT BEING LOST. RATHER THAN YOU HAVING TO SPEND YOUR DAY ON THE PHONE, YOU CAN SIMPLY CHECK WITH US FOR AN UPDATE.
- PAYMENT IS ISSUED IF YOUR BAG IS NOT IN YOUR HAND WITHIN 4 DAYS OF FLIGHT ARRIVAL.
- A CLAIM MUST BE FILED WITH YOUR AIRLINE BEFORE REPORTING YOUR MISHANDLED BAG TO BLUE RIBBON BAGS.
 - MISHANDLED BAGS MUST BE REPORTED TO BLUE RIBBON BAGS WITHIN 24 HOURS OF NOTIFYING THE AIRLINE. ANY REPORTS FILED AFTER THE 24 HOUR DEADLINE WILL NOT BE HONORED.
- EACH PURCHASE IS PER PERSON, PER PNR REGARDLESS OF THE NUMBER OF CONNECTIONS. PAYOUTS ARE PER BAG.
- ONE SERVICE AGREEMENT (\$5.00) INCLUDES ALL BAGS CHECKED AT THE AIRPORT, INCLUDING LAST MINUTE GATE CHECK-INS. HIGHER LIMIT OPTIONS ARE AVAILABLE: \$7.50 & \$10.00 RECEIVE PAYMENT OF \$1,500 AND \$2,000.
- BLUE RIBBON BAGS COVERS ALL FLIGHTS WORLDWIDE.
- MISHANDLED BAGGAGE REPORTS ARE FILED SIMPLY BY GOING TO WWW.BLUERIBBONBAGS.COM, OR BY CALLING (888)-BAGGAGE, 24/7.
- BRB PAYS 20% COMMISSION ON EACH SALE. COMMISSION IS PAID QUARTERLY.
 - CONSIDER ADDING \$5 TO YOUR SERVICE FEE AND INCLUDE BRB IN EVERY TICKET YOU SELL.
 - ASK ABOUT OUR BILLING SYSTEM TO AVOID YOUR CLIENTS SEEING A SEPARATE CHARGE FOR BRB ON THEIR CREDIT CARD.
- BRB SELLS A SERVICE. HAVING A BRB SERVICE AGREEMENT IS IN ADDITION TO ANY INSURANCE THE CLIENT MAY HAVE, NOT INSTEAD OF. AFTER COLLECTING THEIR BRB CHECK, CLIENTS ARE STILL ABLE TO ACCEPT INSURANCE PAYOUTS.
- NO PROOF OF BAG CONTENTS IS REQUIRED TO RECEIVE PAYMENT.
